2021 Energy Efficiency Rebate Form

ELIGIBILITY AND INSTRUCTIONS FOR COMPLETING THIS FORM *(Please read)*

- ❖ Rebate not to exceed cost of bulb, fixture, or unit.
 - ❖ Night lights, flashlights, rechargeable lighting, and solar lighting are not eligible.
 - ❖ Equipment must be purchased new in 2021 and installed on Polk-Burnett lines.
 - ❖ Must submit **at least 5 bulbs at one time** to receive any rebates. *(All 5 bulbs do not need to be purchased at same time)*
 - ❖ Residential rebates for bulbs. Commercial/industrial/agricultural rebates for bulbs and/or fixtures.
 - ❖ Rebates are in place through December 31, 2021 or until funds are depleted.
 - ❖ Program subject to change or cancellation without prior notification.
 - ❖ Rebates will appear as a one-time credit on your electric bill within 1-3 billing cycles after approval.
 - ❖ Submit the documentation listed below **within 3 months after date of purchase or January 1, 2022, whichever comes first.**
- However, members are encouraged to submit as soon as possible to ensure rebate:
- ✓ This rebate form *(Note: Your self-calculated rebate total may change after review of documentation submitted)*
 - ✓ A copy of your **detailed** receipt or invoice for each item purchased – *if receipt not specific - will need to include copy of packaging*
 - ✓ **DO NOT** high-light the eligible items on your receipt
